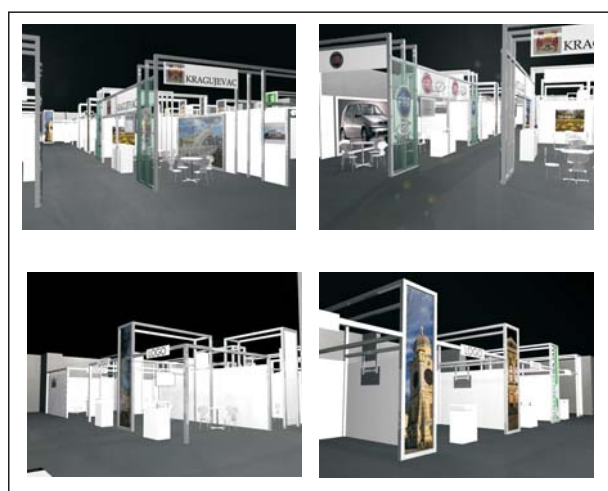

TERMS AND CONDITIONS OF EXHIBITING

- 1. The terms and Conditions of Exhibiting are enclosed with the Exhibition Contract. Signature of the Exhibition Contract implies acceptance of these conditions.**

- 2. Fair exhibitor shall submit an application form for participation in the fair (event). Completed application has to be signed by an authorized person and certified. Sumadija fair shall return verified copy to the Exhibitor.**

- 3. All companies are required to pay Value Added Tax at the prevailing rate. Exhibitor is required to pay non-refundable 50% of the amount in the pro-forma invoice within 7 days of receipt of pro-forma invoice. Remaining amount the exhibitor is obliged to pay prior to the (fair) event.**

- 4. Cancellation must be made in writing to the Project manager and the following forfeit of costs the Exhibitor is obliged to pay as follows:**
 - 50% of the contract price if the cancellation is received more than 15 days prior to the fair (event).**
 - 100% of the contract price if the cancellation is received within less than 15 days before the fair (event).****The date of cancellation shall be the date of receipt of the cancellation of the contract.**

- 5. Exhibitors must insure their exhibits and other property from theft, damage... Responsibility for loss or damage to the exhibits or other property of exhibitors if not insured, shall be borne by the exhibitor.**

- 6. Organizer reserves the right to cancel and delay the event, with the official letter to inform the participants, but no later then 15 days before the opening. Exhibitor agrees with the changed term unless if in a written cancels participation.**

- 7. Commercial Court in Kragujevac will be competent for any disputes arising between Sumadija fair and its exhibitors.**

- 8. Payment should be made by bank transfer to the designated bank account according to the invoice and payment request issued by Sumadia fair. Checks are not accepted. All bank transfer fees are responsibility of the Exhibitor.**
